IN exercise of the powers conferred by section 51 of the Interpretation Acts 1948 and 1967 [*Act 388*], the Yang di-Pertuan Agong has directed that during the periods specified in column (1) of the Schedule the function of the Minister specified in column (2) shall be exercisable by the Minister specified in column (3).
