AKTA MENTERI KEWANGAN (PEMERBADANAN) 1957

PENETAPAN DI BAWAH SEKSYEN 5

PADA menjalankan kuasa yang diberikan oleh seksyen 5 Akta Menteri Kewangan (Pemerbadanan) 1957 [Akta 375], Menteri menetapkan Ketua Setiausaha Perbendaharaan, Timbalan Ketua Setiausaha Perbendaharaan (Sistem & Kawalan), Setiausaha dan Timbalan Setiausaha Bahagian Pelaburan, MKD dan Penswastaaan, Kementerian Kewangan, sebagai pegawai—

- (a) yang di hadapannya semua surat ikatan, dokumen dan surat cara lain yang berkaitan dengan pentadbiran dan pelaksanaan segala keputusan Menteri Kewangan bagi maksud menyampaikan atau melaksanakan atau menyempurnakan keputusan yang dibuat oleh Perbadanan yang memerlukan meterai Perbadanan hendaklah dimeteraikan; dan
- (b) yang dari kalangan mereka sekurang-kurangnya dua hendaklah menandatangani semua surat ikatan, dokumen dan surat cara lain yang padanya meterai itu dicapkan.

MINISTER OF FINANCE (INCORPORATION) ACT 1957

DESIGNATION UNDER SECTION 5

IN exercise of the powers conferred by section 5 of the Minister of Finance (Incorporation) Act 1957 [Act 375], the Minister of Finance designates the Secretary General to the Treasury, the Deputy Secretary General to the Treasury (System & Control), Under Secretary and Deputy Under Secretary of the Investment, MOF (Inc.) and Privatization Division, Ministry of Finance, as the officers—

- (a) in whose presence all deeds, documents and other instruments in connection with the administration and implementation of any decisions made by Minister of Finance to convey, implement and execute the decision of the Corporation requiring the seal of the Corporation shall be sealed; and
- (b) from among whom at least two shall sign all such deeds, documents and other instruments to which the seal is affixed.
