4. Lembaga Pengurus

(5) All existing liabilities incurred by or on behalf of or for the purposes of the University Hospital under the revoked Statute shall, on the coming into operation of this Statute, be enforced against the University Malaya Medical Centre.

(6) All references to the University Hospital in any instrument, deed, title, document, bond, agreement and working arrangement made under the revoked Statute and subsisting immediately before the coming into operation of this Statute shall, on the coming into operation of this Statute, be construed as references to the University Malaya Medical Centre.

(7) The instrument, deed, title, document, bond, agreement and working arrangement referred to in subsection (6) shall, on the coming into operation of this Statute:

- (a) be deemed to have been made under this Statute; and
- (b) continue to be in force and have effect.

(8) All orders, notices, forms and authorization letters issued or made under the revoked Statute shall remain in force in so far as they are not inconsistent with the provisions of this Statute.
