PADA menjalankan kuasa yang diberikan oleh perenggan 72(2)(d) Akta Pembangunan Kemahiran Kebangsaan 2006 [*Akta 652*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Penepian Fi kepada Penyedia Latihan Berdaftar) 2026**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 15 Julai 2026.

Penepian fi

2. (1) Tertakluk kepada subperaturan (2), fi yang ditetapkan dalam subsubbutiran 1(c)(i) dan (ii) Jadual Pertama kepada Peraturan-Peraturan Pembangunan Kemahiran Kebangsaan (Fi dan Caj) 2016 [*P.U. (A) 86/2016*] diketepikan berkenaan dengan suatu penyedia latihan berdaftar di bawah seksyen 31C Akta Keselamatan dan Kesihatan Pekerjaan 1994 [*Akta 514*].

(2) Penepian fi di bawah subperaturan (1) adalah terpakai bagi permohonan pentauliahan program latihan kemahiran yang dibuat dalam tempoh tiga tahun mulai 15 Julai 2026 hingga 14 Julai 2029.

NATIONAL SKILLS DEVELOPMENT ACT 2006

NATIONAL SKILLS DEVELOPMENT
(WAIVER OF FEE TO REGISTERED TRAINING PROVIDER) REGULATIONS 2026

IN exercise of the powers conferred by paragraph 72(2)(d) of the National Skills Development Act 2006 [Act 652], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **National Skills Development (Waiver of Fee to Registered Training Provider) Regulations 2026**.

(2) These Regulations come into operation on 15 July 2026.

Waiver of fee

2. (1) Subject to subregulation (2), the fee prescribed in subsubitem 1(c)(i) and (ii) of the First Schedule to the National Skills Development (Fees and Charges) Regulations 2016 [P.U. (A) 86/2016] is waived in respect of a registered training provider under section 31C of the Occupational Safety and Health Act 1994 [Act 514].

(2) The waiver of fee under subregulation (1) applies to the application for the skills training accreditation made within the period of three years from 15 July 2026 to 14 July 2029.
