Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Eksais (Pindaan) 2018**.

(2) Perintah ini mula berkuat kuasa pada 1 September 2018.

EXCISE ACT 1976

EXCISE DUTIES (AMENDMENT) ORDER 2018

IN exercise of the powers conferred by subsection 6(1) of the Excise Act 1976 [Act 176], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Excise Duties (Amendment) Order 2018**.

(2) This Order comes into operation on 1 September 2018.

Amendment of Schedule

2. The Excise Duties Order 2017 [P.U.(A) 92/2017] is amended in the Schedule —

(a) in relation to subheading 2403.19, by substituting for subheadings 2403.19.20 and 2403.19.20 90 and the particulars relating to it the following particulars:

	"2403.19.20 00	- - - Other manufactured tobacco for the manufacture of cigarettes	kg	RM15.00 and 5%"; and
