ONLINE SAFETY ACT 2025

ONLINE SAFETY (APPOINTMENT OF CHAIRMAN AND MEMBERS
OF THE ONLINE SAFETY APPEAL TRIBUNAL) ORDER 2026

IN exercise of the powers conferred by subsection 40(2) of the Online Safety Act 2025 [*Act 866*], the Minister makes the following order:

Citation

1. This order may be cited as the **Online Safety (Appointment of Chairman and Members of the Online Safety Appeal Tribunal) Order 2026**.

Appointment of Chairman and members of Online Safety Appeal Tribunal

2. The Minister appoints Yang Arif Puan Alice Loke Yee Ching as the Chairman of the Online Safety Appeal Tribunal and the persons named in the Schedule as members of the Online Safety Appeal Tribunal for a period of three years with effect from 15 July 2026.
