FEDERAL CONSTITUTION

CONSTITUTION OF THE HIGH COURTS (JUDICIAL COMMISSIONERS) ORDER 2016

IN exercise of the powers conferred by Clause (1) of Article 122AB of the Federal Constitution, the Yang di-Pertuan Agong acting on the advice of the Prime Minister, after consulting the Chief Justice of the Federal Court, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Constitution of the High Courts (Judicial Commissioners) Order 2016**.

(2) This Order is deemed to have come into operation on 16 December 2015.

Appointment of Judicial Commissioners

Datin Siti Mariam binti Haji Othman, Encik Hassan bin Abdul Ghani, Puan Chan Jit Li, Encik Muhammad Jamil bin Hussin, Puan Hayatul Akmal binti Abdul Aziz, YBhg. Dato' Wan Ahmad Farid bin Wan Salleh and YBhg. Dato' Haji Mohamad Shariff bin Haji Abu Samah are appointed to be Judicial Commissioners for a period of two years with effect from 16 December 2015.
