PRINTING PRESSES AND PUBLICATIONS
(CONTROL OF UNDESIRABLE PUBLICATIONS) (REVOCATION) (NO. 6) ORDER 2026

IN exercise of the powers conferred by subsection 7(1) of the Printing Presses and Publications Act 1984 [*Act 301*], the Minister revokes the Printing Presses and Publications (Control of Undesirable Publications) (No. 4) Order 2023 [*P.U. (A) 283/2023*] which has been published in the *Gazette* on 25 September 2023 which prohibited the printing, importation, production, reproduction, publishing, sale, issue, circulation, distribution or possession of the publication of *When I Was A Kid 3*.
