## SERVICE COMMISSIONS ACT 1957

## SERVICE COMMISSIONS (AMENDMENT OF SCHEDULE) REGULATIONS 2016

IN exercise of the powers conferred by section 13 of the Service Commissions Act 1957 [Act 393], the Yang di-Pertuan Agong makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Service Commissions (Amendment of Schedule) Regulations 2016**.

(2) These Regulations are deemed to have come into operation on 1 July 2016.

**Amendment of Schedule**

2. The Schedule to the Act is amended under the heading "SALARIES AND FIXED ALLOWANCES"—

(a) in respect of the heading "PUBLIC SERVICES COMMISSION", by substituting for subparagraphs 1, 2 and 3 the following subparagraphs:
