## REGISTRATION OF PHARMACISTS ACT 1951

### REGISTRATION OF PHARMACISTS (AMENDMENT OF FIRST SCHEDULE) (No. 2) ORDER 2019

IN exercise of the powers conferred by subsection 6(3) of the Registration of Pharmacists Act 1951 [Act 371], the Minister, after consulting the Board, makes the following order:

#### Citation

1. This order may be cited as the **Registration of Pharmacists (Amendment of First Schedule) (No. 2) Order 2019**.

#### Amendment of First Schedule

2. The First Schedule to the Registration of Pharmacists Act 1951 is amended—

- (a) in relation to the country of “Malaysia”, by inserting after the item “KPJ University College” and the particulars relating to it the following item and particulars:

<i>Name of Institution granting qualification</i>	<i>Description of qualification</i>
“QUEST International University Perak (QIUP)	Bachelor of Pharmacy (Hons) (Recognised on 8 February 2019)”; and

- (b) in relation to the country of “United Kingdom”, by inserting after the item “University College London” and the particulars relating to it the following item and particulars:

<i>Name of Institution granting qualification</i>	<i>Description of qualification</i>
“University of East Anglia (UEA)	Master of Pharmacy (MPharm) (Recognised on 1 January 2022)
