DENTAL ACT 1971

DENTAL (AMENDMENT OF SECOND SCHEDULE) (No. 2) ORDER 2019

IN exercise of the powers conferred by subsection 12(2) of the Dental Act 1971 [Act 51], the Minister, after consulting the Council, makes the following order:

Citation

1. This order may be cited as the **Dental (Amendment of Second Schedule) (No. 2) Order 2019**.

Amendment of Second Schedule

2. The Second Schedule to the Dental Act 1971 is amended in relation to the country of “India”, by substituting for the item “Meenakshi Ammal Dental College & Hospital, Meenakshi Academy of Higher Education & Research (formerly known as Meenakshi Ammal Dental College, Dr. M.G.R. Tamil Nadu University)” and the particulars relating to it, the following item and particulars:

Institution granting qualification

“Meenakshi Ammal Dental College & Hospital, Meenakshi Academy of Higher Education & Research that is deemed to be a university and which was formerly known as Meenakshi Ammal Dental College & Hospital, Meenakshi Academy of Higher Education & Research

Description of qualification

Bachelor of Dental Surgery (B.D.S)”.
