REGISTRATION OF PHARMACISTS (AMENDMENT OF FIRST SCHEDULE) ORDER 2017

IN exercise of the powers conferred by subsection 6(3) of the Registration of Pharmacists Act 1951 [*Act 371*], the Minister, after consulting the Board, makes the following order:

**Citation**

1. This order may be cited as the **Registration of Pharmacists (Amendment of First Schedule) Order 2017**.

**Amendment of First Schedule**

2. The First Schedule to the Registration of Pharmacists Act 1951 is amended, in relation to the country of “Malaysia”, by inserting after the item “Cyberjaya University College of Medical Sciences” and the particulars relating to it the following items and particulars:

“MAHSA University	Bachelor of Pharmacy (Hons)
SEGi University	Bachelor of Pharmacy (Hons)”.
