DENTAL ACT 1971

DENTAL (AMENDMENT OF SECOND SCHEDULE) (NO. 2) ORDER 2016

IN exercise of the powers conferred by subsection 12(2) of the Dental Act 1971 [*Act 51*], the Minister, after consulting the Council, makes the following order:

Citation

1. This order may be cited as the **Dental (Amendment of Second Schedule) (No. 2) Order 2016**.

Amendment of Second Schedule

2. The Second Schedule to the Act is amended in relation to the country of “Malaysia” by inserting after the item “International Medical University” and the item relating to it the following items:

<i>Institution granting qualification</i>	<i>Description of qualification</i>
“SEGi University	Bachelor of Dental Surgery (B. D. S.) (Recognized on 2 June 2016)”.
