ELECTION COMMISSION (AMENDMENT OF SCHEDULE) (NO. 2)
REGULATIONS 2014

IN exercise of the powers conferred by section 12 of the Election Commission Act 1957 [Act 31], the Yang di-Pertuan Agong makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Election Commission (Amendment of Schedule) (No. 2) Regulations 2014**.

(2) These Regulations are deemed to have come into operation on 1 June 2014.

Amendment of Schedule

2. The Schedule to the Act is amended in paragraph 1 by substituting for the figure “15,900.42” the figure “16,868.35”.
