PERATURAN-PERATURAN SURUHANJAYA PILIHAN RAYA (PINDAAN JADUAL) 2014

PADA menjalankan kuasa yang diberikan oleh seksyen 12 Akta Suruhanjaya Pilihan Raya 1957 [*Akta 31*], Yang di-Pertuan Agong membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Suruhanjaya Pilihan Raya (Pindaan Jadual) 2014**.

(2) Peraturan-Peraturan ini disifatkan telah mula berkuat kuasa pada 1 Januari 2013.

2. Jadual kepada Akta dipinda dalam perenggan 1—

(a) dengan menggantikan angka “14,607.70” dengan angka “18,891.29”;

(b) dengan menggantikan angka “12,201.84” dengan angka “15,900.42”; dan

(c) dengan menggantikan angka “11,264.26” dengan angka “14,587.54”.

ELECTION COMMISSION ACT 1957

ELECTION COMMISSION (AMENDMENT OF SCHEDULE) REGULATIONS 2014

IN exercise of the powers conferred by section 12 of the Election Commission Act 1957 [Act 31], the Yang di-Pertuan Agong makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Election Commission (Amendment of Schedule) Regulations 2014**.

(2) These Regulations are deemed to have come into operation on 1 January 2013.

**Amendment of Schedule**

2. The Schedule to the Act is amended in paragraph 1—

(a) by substituting for the figure “14,607.70” the figure “18,891.29”;

(b) by substituting for the figure “12,201.84” the figure “15,900.42”; and

(c) by substituting for the figure “11,264.26” the figure “14,587.54”.
