## DENTAL ACT 1971

## DENTAL (AMENDMENT OF SECOND SCHEDULE) ORDER 2014

IN exercise of the powers conferred by subsection 12(2) of the Dental Act 1971 [Act 51], the Minister, after consulting the Council, makes the following order:

**Citation**

1. This order may be cited as the **Dental (Amendment of Second Schedule) Order 2014**.

**Amendment of the Second Schedule**

2. The Second Schedule to the Act is amended in relation to the country of “India”—
  - (a) by inserting after the item “A.B. Shetty Memorial Institute of Dental Science, Mangalore” and the particulars appearing against it, the following item and particulars:
