## DENTAL ACT 1971

## DENTAL (AMENDMENT OF SECOND SCHEDULE) (NO. 2) ORDER 2013

IN exercise of the powers conferred by subsection 12(2) of the Dental Act 1971 [*Act 51*], the Minister, after consulting the Council, makes the following order:

**Citation**

1. This order may be cited as the **Dental (Amendment of Second Schedule) (No. 2) Order 2013**.

**Amendment of Second Schedule**

2. The Second Schedule to the Act is amended by inserting after the item "Canada" and the item relating to it the following items:

<i>Country in which the qualification is granted</i>	<i>Institution granting qualification</i>	<i>Description of qualification</i>
"Denmark	University of Copenhagen	<i>Master of Sciences in Dentistry (M. Sc.)</i> ".
