DENTAL ACT 1971

DENTAL (AMENDMENT OF SECOND SCHEDULE) ORDER 2013

IN exercise of the powers conferred by subsection 12(2) of the Dental Act 1971 [*Act 51*], the Minister, after consulting the Council, makes the following order:

Citation

1. This order may be cited as the **Dental (Amendment of Second Schedule) Order 2013**.

Amendment of the Second Schedule

2. The Dental Act 1971 [*Act 51*] is amended in the Second Schedule in relation to the country of “Malaysia” by inserting after the item “MAHSA University College” and the item relating to it, the following items:

“International Medical University Bachelor of Dental Surgery (B. D. S.)
(Recognized on 4 October 2012)”.
