DENTAL (AMENDMENT OF SECOND SCHEDULE) (NO. 3) ORDER 2012

IN exercise of the powers conferred by subsection 12(2) of the Dental Act 1971 [*Act 51*], the Minister, after consulting the Council, makes the following order:

Citation

1. This order may be cited as the **Dental (Amendment of Second Schedule) (No. 3) Order 2012**.

Amendment of the Second Schedule

2. The Dental Act 1971 [*Act 51*] is amended in the Second Schedule in relation to the country of “Malaysia” by inserting after the item “Universiti Sains Islam Malaysia” and the item relating to it the following item:

“Mahsa University College

Doctor of Dental Surgery (D.D.S)
(Recognized on 15 June 2012)”.
