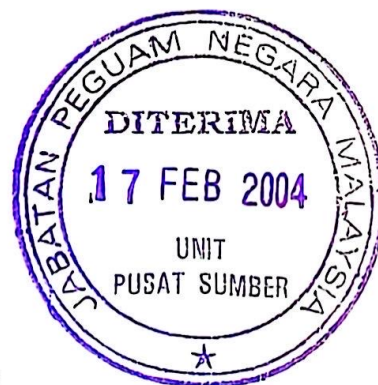

MAINTENANCE ORDERS (FACILITIES FOR ENFORCEMENT)
(EXTENSION OF THE ACT) ORDER ~~2003~~ 2004

In exercise of the powers conferred by section 11 of the Maintenance Orders (Facilities for Enforcement) Act 1949 [Act 34], the Yang di-Pertuan Agong makes the following order:

Citation

1. This order may be cited as the **Maintenance Orders (Facilities for Enforcement) (Extension of the Act) Order** ~~2003~~ 2004

Extension of the Act

2. The Yang di-Pertuan Agong, being satisfied under section 11 of the Act that reciprocal provisions have been made by the legislature of Hong Kong Special Administrative Region of the People’s Republic of China for enforcement within Hong Kong Special Administrative Region of the People’s Republic of China of maintenance orders made by the courts in Malaysia, extends the Act to Hong Kong Special Administrative Region of the People’s Republic of China.

Amendment of Schedule

3. The Schedule to the Act is amended by substituting for the words “Hong Kong, Colony of” the words “Hong Kong Special Administrative Region of the People’s Republic of China”.
