EDUCATIONAL INSTITUTIONS (DISCIPLINE) ACT 1976**EDUCATIONAL INSTITUTIONS (DISCIPLINE) (FIRST SCHEDULE)
(AMENDMENT) (No. 2) ORDER 2002**

IN exercise of the powers conferred by subsection 22(2) of the Educational Institutions (Discipline) Act 1976 [*Act 174*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Educational Institutions (Discipline) (First Schedule) (Amendment) (No. 2) Order 2002**.

(2) This Order is deemed to have come into operation on 1 June 2002.

Amendment of First Schedule

2. The First Schedule to the Educational Institutions (Discipline) Act 1976 is amended in item 38 by substituting for the words “Maktab Perguruan Tengku Ampuan Afzan, Kuantan, Pahang” appearing in the second column the words “Maktab Perguruan Tengku Ampuan Afzan, Kuala Lipis, Pahang”.
