Decision shall be final

18. The decision of the Disciplinary Appeal Board shall be final.

Decisions to be communicated in writing

19. All decisions of the Disciplinary Committee and the Disciplinary Appeal Board in respect of an officer or servant shall be communicated to the officer or servant in writing.

Savings

20. Any proceedings or cause of action pending or existing immediately before the coming into operation of these Rules may be continued or instituted as if these Rules had not been made.

DANGEROUS DRUGS ACT 1952**DANGEROUS DRUGS (AMENDMENT OF FIRST SCHEDULE) ORDER 2001**

IN exercise of the powers conferred by section 45A of the Dangerous Drugs Act 1952 [*Act 234*], the Minister makes the following order:

Citation

1. This order may be cited as the **Dangerous Drugs (Amendment of First Schedule) Order 2001**.

Amendment of First Schedule

2. The First Schedule to the Dangerous Drugs Act 1952 is amended—

(a) in Part III by inserting—

- (i) after the item “Isomethadone” the item “Ketamine”; and
- (ii) after the item “Nicomorphine” the item “Nimetazepam”; and

(b) in Part V by deleting paragraph 1.
