EDUCATIONAL INSTITUTIONS (DISCIPLINE) (FIRST SCHEDULE) (AMENDMENT)
ORDER 2001

In exercise of the powers conferred by subsection 22(2) of the Educational Institutions (Discipline) Act 1976 [*Act 174*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Educational Institutions (Discipline) (First Schedule) (Amendment) Order 2001**.

(2) This order shall be deemed to have come into operation on 1 January 2000.

Amendment of First Schedule

2. The First Schedule to the Educational Institutions (Discipline) Act 1976 is amended in item 53 by substituting for the words “Politeknik Kuala Terengganu” appearing in the second column the words “Politeknik Kota, Kuala Terengganu”.

59. Kolej Matrikulasi Negeri Sembilan	The whole Act except sections 4, 17, 18, 19 and 20
60. Kolej Matrikulasi Pulau Pinang	The whole Act except sections 4, 17, 18, 19 and 20
61. Kolej Matrikulasi Perlis	The whole Act except sections 4, 17, 18, 19 and 20”.
