FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) ORDER 2001

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [*Act 376*], the Minister, after consultation with the State Government of Selangor Darul Ehsan, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) Order 2001**.

(2) This Order comes into operation on 5 April 2001.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/89*] is amended in the First Schedule under the heading of “Negeri Selangor Darul Ehsan” by deleting item 16 in respect of “Memanda 9 Road”.

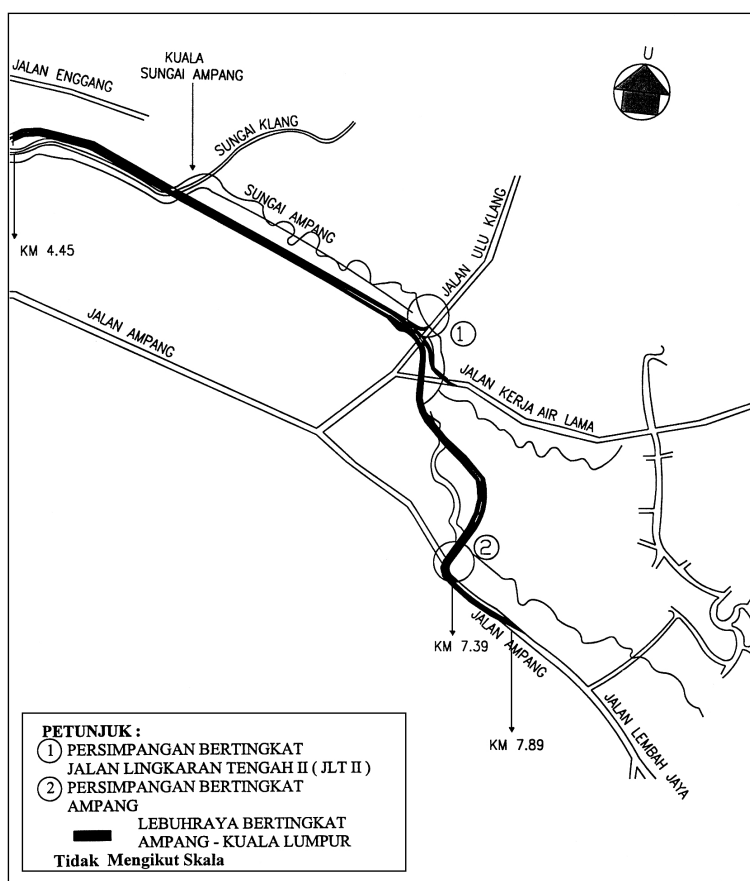

FEDERAL ROADS (AMPANG–KUALA LUMPUR ELEVATED HIGHWAY)
ORDER 2001

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [*Act 376*], the Minister, after consultation with the State Government of Selangor Darul Ehsan, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Ampang–Kuala Lumpur Elevated Highway) Order 2001**.

(2) This Order comes into operation on 5 April 2001.

Declaration of road to be Federal road

2. (1) That part of the road known as the Ampang–Kuala Lumpur Elevated Highway commencing—

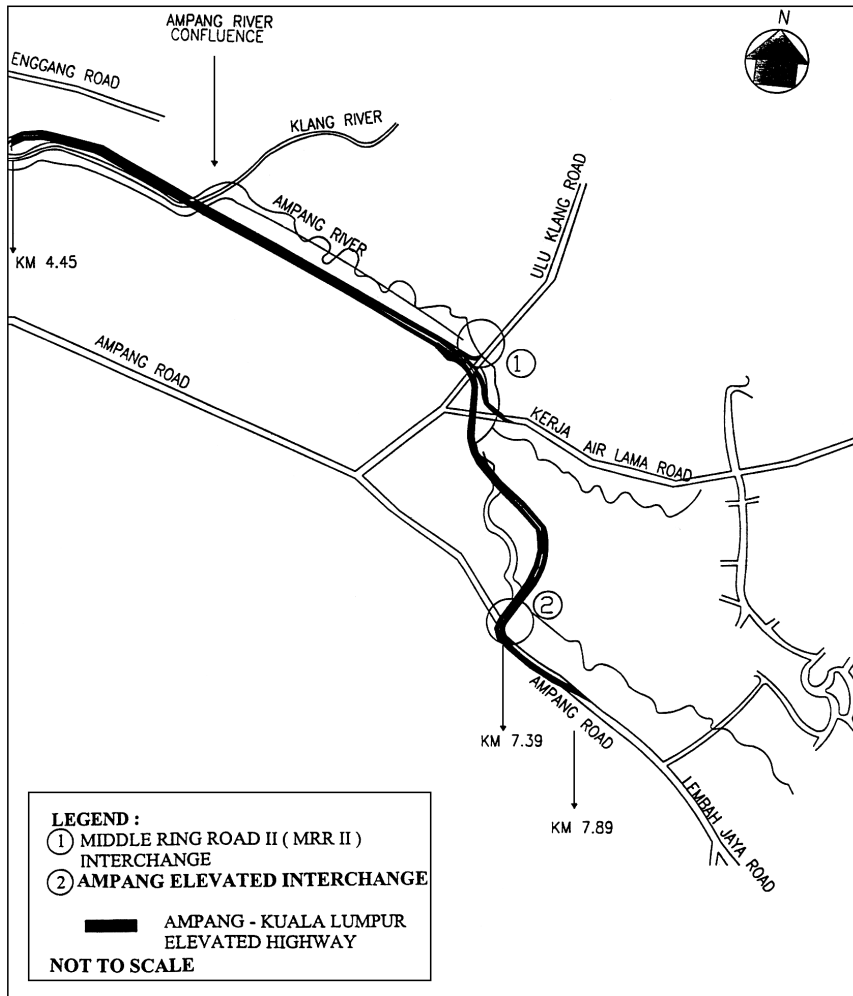
- (a) from kilometre 4.44 (at coordinate E+3569.983, N-1031.629) and ending at kilometre 7.39 (at coordinate E+5865.745, N-2030.006 (eastbound), being a distance of 2.95 kilometres; and
- (b) from kilometre 4.45 (at coordinate E+3572.941, N-1051.882) and ending at kilometre 7.89 (at coordinate E+6124.732, N-2342.717) (westbound), being a distance of 3.44 kilometres,

including the Middle Ring Road (MRR II) Interchange and the Ampang Elevated Interchange, is declared to be a Federal road.

(2) The road declared to be a Federal road under subparagraph (1) is as shown on the map in the Schedule.
