SERVICE COMMISSIONS ACT 1957

SERVICE COMMISSIONS (AMENDMENT OF SCHEDULE) (No. 2) REGULATIONS 2000

In exercise of the powers conferred by section 13 of the Service Commissions Act 1957 [Act 393], the Yang di-Pertuan Agong makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Service Commissions (Amendment of Schedule) (No. 2) Regulations 2000**.

(2) These Regulations shall be deemed to have come into operation on 1 January 2000.

Amendment of Schedule

2. The Schedule to the Service Commissions Act 1957 is amended under the heading "SALARIES AND FIXED ALLOWANCES"—

(a) in respect of the Public Services Commission, by substituting for subparagraphs 1, 2 and 3 the following subparagraphs:
