EDUCATIONAL INSTITUTIONS (DISCIPLINE) ACT 1976**EDUCATIONAL INSTITUTIONS (DISCIPLINE) (FIRST SCHEDULE)
(AMENDMENT) ORDER 2000**

In exercise of the powers conferred by subsection 22(2) of the Educational Institutions (Discipline) Act 1976 [*Act 174*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Educational Institutions (Discipline) (First Schedule) (Amendment) Order 2000**.

(2) This Order shall be deemed to have come into operation on 1 January 2000.

Amendment of First Schedule

2. The First Schedule to the Educational Institutions (Discipline) Act 1976 is amended in item 29 by substituting for the words “Maktab Perguruan Seri Kota, Kuala Lumpur” appearing in the second column the words “Institut Perguruan Bahasa-Bahasa Antarabangsa, Kuala Lumpur”.
