FREE ZONES (DECLARED AREAS) (AMENDMENT)
NOTIFICATION 2000

IN exercise of the powers conferred by subsection 3(1) of the Free Zones Act 1990 [*Act 438*], the Minister makes the following notification:

Citation and commencement

1. (1) This notification may be cited as the **Free Zones (Declared Areas) (Amendment) Notification 2000**.

(2) This Notification comes into operation on 24 August 2000.

Amendment of Schedule

2. The Schedule to the Free Zones (Declared Areas) Notification 1992 [*P.U. (B) 465/92*] is amended by substituting for the words "*Gazette Plan 295*" appearing in item (ii) under the heading "*Limits of Zones*" the words "*Gazette Plan 429*".
