AKTA CUKAI PENDAPATAN 1967

PERINTAH CUKAI PENDAPATAN (PENGEQUALIAN) (No. 47) 1996

ELECTION COMMISSION ACT 1957

ELECTION COMMISSION (AMENDMENT OF SCHEDULE) (No. 2) REGULATIONS 1996

Act 31. IN exercise of the powers conferred by section 12 of the Election Commission Act 1957, the Yang di-Pertuan Agong makes the following regulations:

Citation and commencement.

1. These regulations may be cited as the **Election Commission (Amendment of Schedule) (No. 2) Regulations 1996** and shall be deemed to have come into force on 1 January 1995.

Amendment of Schedule.

2. The Schedule to the Election Commission Act 1957 is amended in paragraph 1—

(a) by substituting for the figures "6,310" the figures "6,460";

(b) by substituting for the figures "4,700" the figures "4,850";
and

(c) by substituting for the figures "3,950" the figures "4,040".

Akta 393.

PADA menjalankan kuasa yang diberikan oleh seksyen 13 Akta Suruhanjaya Perkhidmatan 1957, Yang di-Pertuan Agong membuat peraturan-peraturan yang berikut:

Nama dan mula berkuatkuasa.

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Suruhanjaya Perkhidmatan (Pindaan Jadual) (No. 2) 1996** dan hendaklah disifatkan telah mula berkuatkuasa pada 1 Januari 1995.

SERVICE COMMISSIONS (AMENDMENT OF SCHEDULE)
(No. 2) REGULATIONS 1996

Act 393. In exercise of the powers conferred by section 13 of the Service Commissions Act 1957, the Yang di-Pertuan Agong makes the following regulations:

Citation and commencement. 1. These regulations may be cited as the **Service Commissions (Amendment of Schedule) (No. 2) Regulations 1996** and shall be deemed to have come into force on 1 January 1995.

Amendment of Schedule. 2. The Schedule to the Service Commissions Act 1957 is amended under the heading "SALARIES AND FIXED ALLOWANCES"—

(a) in respect of the Public Services Commission, by substituting for paragraphs 1, 2 and 3 the following paragraphs:

Fixed allowance.....RM4,390”;

(b) in respect of the Judicial and Legal Service Commission, by substituting for the figures “3950.00” the figures “4,040”;

(c) in respect of the Police Service Commission, by substituting for the figures “3950.00” the figures “4,040”; and

(d) in respect of the Education Service Commission, by substituting for paragraphs 1, 2 and 3 the following paragraphs:

Salary.....RM4,850
3. Members:
Fixed allowance.....RM4,040”.
