## OPTICAL (AMENDMENT OF FIRST SCHEDULE) ORDER 1996

IN exercise of the powers conferred by section 41 of the Optical Act 1991, the Minister, after consulting the Council, makes the following order: Act 469.

1. This order may be cited as the **Optical (Amendment of First Schedule) Order 1996.** Citation.
