- (a) that such designated area, as far as is reasonably practicable, be separated from the area where smoking is prohibited;
- (b) that no person smokes in the area other than the designated area; and
- (c) that a sufficient mechanical ventilation system and extractor fan are provided in the designated area.

(3) Any person who fails to comply with the provisions of subregulation (2) commits an offence.

12. The Minister may, by notification in the *Gazette* and subject to such conditions as he may think fit, specify any building or part thereof to which members of the public have access as a place in which smoking shall not be permitted either permanently or for such period as he may think fit.

Minister may prohibit smoking in a specified building.

13. (1) Any person who contravenes or fails to comply with any provision of these Regulations commits an offence.

Penalty.

(2) Any person who commits an offence under these Regulations for which no penalty is provided by the Act shall, on conviction, be liable to a fine not exceeding five thousand ringgit or to imprisonment for a term not exceeding two years.
