SERVICE COMMISSIONS (AMENDMENT OF SCHEDULE)
REGULATIONS 1992

Ord. 74/1957. IN exercise of the powers conferred by section 13 of the Service Commissions Ordinance 1957, the Yang di-Pertuan Agong makes the following regulations:

Citation. 1. These Regulations may be cited as the **Service Commissions (Amendment of Schedule) Regulations 1992.**

First amendment. 2. (1) The Schedule to the Service Commissions Ordinance 1957 is amended by substituting for paragraphs (A), (B), (C) and (D) under the heading "SALARIES AND FIXED ALLOWANCES" with the following paragraphs:
