## AKTA SENJATA 1960

PERATURAN-PERATURAN PELESENAN SENJATA  
(PINDAAN JADUAL KEDUA) 1992

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 59 Akta Senjata 1960, Menteri membuat peraturan-peraturan yang berikut: Aktin 206

1. Peraturan-Peraturan ini bolehlah dinamakan sebagai **Peraturan-Peraturan Pelesenan Senjata (Pindaan Jadual Kedua) 1992.** Nama.
2. Jadual Kedua kepada Akta Senjata 1960 adalah dipinda— Pindaan Jadual Kedua.
  - (i) dengan memasukkan, selepas sahaja subperenggan (b) perenggan 1, subperenggan baru (bb) yang berikut:
 

“(bb) For each smooth bore shotgun licensed to serving and retired public officers and to any officer serving with any statutory body or local government ... .. \$10.00”;
  - (ii) dengan memasukkan, selepas sahaja subperenggan (b) perenggan 2, subperenggan baru (bb) yang berikut:
 

“(bb) For each smooth bore shotgun licensed to serving and retired public officers, and to any officer serving with any statutory body or local government ... .. \$10.00”;

dan
  - (iii) dengan memotong perkataan-perkataan “(including smooth bore shotgun)” yang terdapat dalam perenggan 1 (d) dan 2 (d).

## ARMS ACT 1960

ARMS LICENSING (AMENDMENT OF SECOND SCHEDULE)  
REGULATIONS 1992

In exercise of the powers conferred by section 59 of the Arms Act 1960, the Minister makes the following regulations: Act 206

1. These Regulations may be cited as the **Arms Licensing (Amendment of Second Schedule) Regulations 1992.** Citation.
2. The Second Schedule to the Arms Act 1960 is amended— Amendment of Second Schedule.
  - (i) by inserting, immediately after subparagraph (b) of paragraph 1, the following new subparagraph (bb):
 

“(bb) For each smooth bore shotgun licensed to serving and retired public officers and to any officer serving with any statutory body or local government ... .. \$10.00”;

(ii) by inserting, immediately after subparagraph (b) of paragraph 2, the following new subparagraph (bb):

“(bb) For each smooth bore shotgun licensed to serving and retired public officers, and to any officer serving with any statutory body or local government ... .. \$10.00”; and

(iii) by deleting the words “(including smooth bore shotgun)” appearing in paragraphs 1 (d) and 2 (d).

Nama dan mula berkuatkuasa.

1. Perintah ini bolehlah dinamakan **Perintah Kastam (Nilai-Nilai) (Minyak Mentah Petroleum) (No. 2) 1992** dan hendaklah mula berkuatkuasa pada 23hb Januari 1992.

## CUSTOMS ACT 1967

CUSTOMS (VALUES) (CRUDE PETROLEUM OIL) (No. 2) ✓  
ORDER 1992

In exercise of the power conferred by section 12 of the Customs Act 1967, the Minister makes the following Order:

Citation and commencement.

1. This Order may be cited as the **Customs (Values) (Crude Petroleum Oil) (No. 2) Order 1992** and shall come into force on the 23rd January 1992.

2. For the purpose of the levy and payment of customs duties, in accordance with the provisions of the Customs Duties Order 1988, the
