CONSTITUTION OF THE HIGH COURTS
(JUDICIAL COMMISSIONERS) (No. 3) ORDER 1991

IN exercise of the powers conferred by Article 122A (5) of the Federal Constitution, the Yang di-Pertuan Agong, acting on the advice of the Lord President of the Supreme Court, makes the following order:

Citation and commencement.

1. This order may be cited as the **Constitution of the High Courts (Judicial Commissioners) (No. 3) Order 1991** and shall be deemed to have come into force on the 16th June 1991.

Appointment of Judicial Commissioner.

2. Dato' Suleiman bin Hashim and Encik Chew Kim Poh are hereby appointed as Judicial Commissioners for a period of two years with effect from the 16th June 1991.

JUDGES' REMUNERATION ACT 1971

JUDGES' REMUNERATION (AMENDMENT OF FIRST SCHEDULE REGULATIONS 1991

IN exercise of the powers conferred by section 19 of the Judges Remuneration Act 1971, the Yang di-Pertuan Agong, after consultation with the Lord President, makes the following regulations: *Act 45.*

1. These Regulations may be cited as the **Judges' Remuneration (Amendment of First Schedule) Regulations 1991** and shall be deemed to have come into force on the 1st January 1991. *Citation and commencement.*

2. The Judges' Remuneration Act 1971 is amended by substituting for the First Schedule the following: *Substitution of First Schedule.*
