SERVICE COMMISSIONS ORDINANCE 1957

**SERVICE COMMISSIONS (AMENDMENT OF SCHEDULE)
REGULATIONS 1989**

IN exercise of the powers conferred by section 13 of the Service Commissions Ordinance 1957, the Yang di-Pertuan Agong makes the following regulations: 74/57.

1. These Regulations may be cited as the **Service Commissions (Amendment of Schedule) Regulations 1989** and shall be deemed to have come into force on the 1st October 1988. Citation and commencement.

2. The Schedule to the Service Commissions Ordinance 1957 is amended by substituting the particulars appearing under the heading "SALARIES AND FIXED ALLOWANCES" with the following: Amendment of Schedule.
