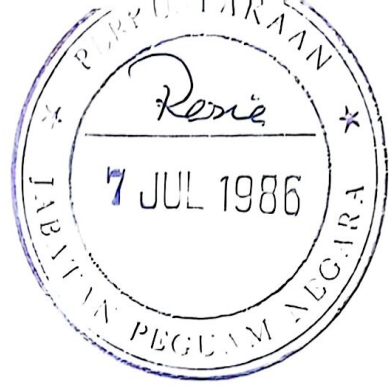

6. Caj bagi penggunaan kemudahan-kemudahan kompleks atau labuhan.
7. Mendirikan struktur, dll. dilarang.
8. Larangan merayau-rayau, memancing, dll.
9. Pematuhan kepada arahan-arahan Ketua Pengarah.
10. Caj perkhidmatan bagi ikan yang diimport.

FEDERATION OF MALAYA RUBBER EXCHANGE (AMENDMENT)
RULES 1986

In exercise of the powers conferred by sections 14 and 16 of the Federation of Malaya Rubber Exchange (Incorporation) Act 1962, ^{11/62.} the Corporation in General Meeting makes the following rules:

1. These Rules may be cited as the **Federation of Malaya Rubber Exchange (Amendment) Rules 1986** and shall be deemed to have come into force on the 22nd February 1986. Citation and commencement.
2. The Federation of Malaya Rubber Exchange Rules 1961 are amended in the manner provided in the Schedule. Amendment of Second Schedule.
