ACT 1976**

**EDUCATIONAL INSTITUTION (DISCIPLINE) (FIRST SCHEDULE)
(AMENDMENT) ORDER 1984**

Act 174. IN exercise of the powers conferred by section 22 (2) of the Educational Institutions (Discipline) Act 1976, the Minister makes the following order:

Citation. 1. This Order may be cited as the **Educational Institutions (Discipline) (First Schedule) (Amendment) Order 1984.**

Amendment of First Schedule. Act 174. 2. The First Schedule to the Educational Institutions (Discipline) Act 1976 is amended by inserting after item 7, the following new items 8 and 9 under the respective First, Second and Third Columns thereof:
