AKTA PENYEMAKAN UNDANG-UNDANG 1968

PERINTAH PENYEMAKAN UNDANG-UNDANG (PEMBETULAN AKTA PENGANGKATAN 1952) 1982

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 15 Akta Penyemakan Undang-Undang 1968, Pesuruhjaya Penyemak Undang-Undang, dengan kelulusan Jawatankuasa Penyemak Undang-Undang, membuat Perintah yang berikut:

1. Perintah ini bolehlah dinamakan **Perintah Penyemakan Undang-Undang (Pembetulan Akta Pengangkatan 1952) 1982** dan hendaklah disifatkan telah mula berkuatkuasa pada 24hb Disember 1981.

2. Akta Pengangkatan 1952 adalah diperbetulkan—

(i) dengan menggantikan perkataan "and" yang terdapat selepas sahaja perkataan "parent" and "child" di baris sebelas seksyen 9 (8) dengan perkataan "an"; dan

(ii) dengan menggantikan seksyen 14 (2) dengan yang berikut:

Pembetulan
Seksyen 9 (8)
dan 14 (2).

"(2) The Court may—

(a) in the case of the child, if satisfied by a report from the guardian *ad litem* that special circumstances exist which render it inexpedient or unnecessary that the child shall personally attend before the Court;

(b) in the case of any other respondent, if satisfied that the respondent cannot be found or is incapable of giving consent; or

(c) for any other reason which the Court may deem sufficient,
dispense with the attendance of any respondent.”.

REVISION OF LAWS ACT 1968

REVISION OF LAWS (RECTIFICATION OF ADOPTION ACT 1952)
ORDER 1982

Act 1.

In exercise of the powers conferred by section 15 of the Revision of Laws Act 1968, the Commissioner of Law Revision, with the approval of the Law Revision Committee, makes the following Order:

Citation and commencement.

1. This Order may be cited as the **Revision of Laws (Rectification of Adoption Act 1952) Order 1982** and shall be deemed to have come into force on the 24th December 1981.

Rectification of Sections 9 (8) and 14 (2).
Act 257.

2. The Adoption Act 1952 is rectified—

(i) by substituting the word “an” for the word “and” appearing immediately after the words “parent” and “child” in line eleven of section 9 (8); and

(ii) by substituting the following for section 14 (2)—

“(2) The Court may—

(a) in the case of the child, if satisfied by a report from the guardian *ad litem* that special circumstances exist which render it inexpedient or unnecessary that the child shall personally attend before the Court;

(b) in the case of any other respondent, if satisfied that the respondent cannot be found or is incapable of giving consent; or

(c) for any other reason which the Court may deem sufficient,

dispense with the attendance of any respondent.”.
