ROAD TRAFFIC ORDINANCE 1958

PROHIBITION ON THE USE OF THE JALAN BARAT AND THE JALAN UTARA INTERSECTION WITH THE FEDERAL HIGHWAY ORDER 1982

49/58. WHEREAS by *Gazette* Notification No. 412 of 28th January 1982, notice was given of the intention to make an Order under section 61 (2) of the Road Traffic Ordinance 1958.

AND WHEREAS no objections were received against the making of such Order.

NOW, THEREFORE, in exercise of the powers conferred by section 61 of the Road Traffic Ordinance 1958, the Minister after taking into consideration the matters referred to in section 61 (2) of the Ordinance, makes the following Order:

Citation. 1. This Order may be cited as the **Prohibition on the use of the Jalan Barat and the Jalan Utara Intersection Order 1982.**

Prohibition. 2. No vehicle is permitted to use the Jalan Barat and the Jalan Utara Intersection with the Federal Highway.

STAMP DUTY (AMENDMENT) ORDER 1982

2. Kanun Tanah Negara adalah dipinda dengan menggantikan **Jadual Kelima dengan Jadual Kelima yang berikut—** Pindaan bagi Jadual Kelima.

FIFTH SCHEDULE
(Section 211)

OFFICERS OR OTHER PERSONS TO ATTEST
EXECUTIONS OF INSTRUMENTS EFFECTING
DEALINGS UNDER ACT

1. Every execution by a natural person of any instrument effecting any dealing under this Act, other than an instrument in respect of any land referred to in paragraph 3, shall be attested by any of the following officers or other persons:

(1) In any State to which this Act applies—

- (a) a Magistrate;
- (b) the State Commissioner;
- (c) the Registrar;
- (d) a Collector;
- (e) an advocate and solicitor;
- (f) a notary public.
