IN exercise of the powers conferred by section 45A of the Dangerous Drugs Act 1952 (Revised—1980), the Minister makes the following Order:

Citation.

1. This Order may be cited as the **Dangerous Drugs Order 1981**.

2. Part III of the First Schedule to the Act is amended by—

(a) inserting the item “Sufentanil” immediately after the item “Racemorphan”; and

3. Part IV of the First Schedule to the Act is amended by inserting the item “Dextropropoxyphene” immediately after the item “Codeine”.
