MEDICAL REGULATION, 1974

INCORPORATION (STATE LEGISLATURES
COMPETENCY) ACT, 1962

15/62. IN exercise of his powers under section 7 of the Incorporation (State Legislatures Competency) Act, 1962, the Yang di-Pertuan Agong hereby makes the following order :
