REVISION OF LAWS ACT, 1968

IN exercise of the powers conferred by section 15 of the Revision of Laws Act, 1968, the Commissioner of Law Revision, with the approval of the Law Revision Committee, hereby makes the following order: Act 1.

1. This order may be cited as the **Revision of Laws (Evidence Act) Order, 1974**, and shall have the force of law with effect from the 1st November, 1971. Citation and effective date.
2. Section 73A (5) of the Evidence Act, 1950, is hereby rectified by substituting the word "inexpedient" for the word "expedient". Rectification of Act 56.

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen-seksyen 14 dan 16 kepada Akta Pasaran Getah Persekutuan Tanah Melayu (Perbadanan), 1962, Perbadanan dalam Mesyuarat Agong dengan ini membuat kaedah-kaedah yang berikut: 11/62.

FEDERATION OF MALAYA RUBBER EXCHANGE
(INCORPORATION) ACT, 1962

11/62. IN exercise of the powers conferred by sections 14 and 16 of the Federation of Malaya Rubber Exchange (Incorporation) Act, 1962, the Corporation in General Meeting hereby makes the following rules:

Citation and Commencement

1. These rules may be cited as the **Federation of Malaya Rubber Exchange (Amendment) Rules, 1974**, and shall be deemed to have come into force on 27th April, 1974.
