

ROAD TRAFFIC ORDINANCE, 1958

- 49/58. IN exercise of the powers conferred by section 60 (1) of the Road Traffic Ordinance, 1958, the Minister of Communications hereby makes the following order:
- Citation. 1. This order may be cited as the **Speed Limit (Trengganu) (No. 2) Order, 1974.**
- Prohibition. 2. The driving of motor vehicles at a speed greater than the speeds specified in the first column of the Schedule hereto on the roads specified in the second column of the said Schedule is hereby prohibited.

SCHEDULE

(1) <i>Speed limit</i>	(2) <i>Road on which speed limit applies</i>
A maximum speed of 30 miles an hour	(1) That stretch of Federal road passing through the Paka area from milestone 59.75 to milestone 60.95. (2) That stretch of Federal road passing through the Kuala Abang area from milestone 37.60 to milestone 38.25. (3) That stretch of Federal road between Marang and Dungun from milestone 23.25 to milestone 26.25.
