### AKTA CUKAI JUALAN, 1972

PADA menjalankan kuasa-kuasa yang di beri oleh seksyen 8 Akta Cukai Jualan, 1972, Menteri Kewangan dengan ini membuat perintah yang berikut:

### SALES TAX ACT, 1972

IN exercise of the powers conferred by section 8 of the Sales Tax Act, 1972, the Minister of Finance hereby makes the following order:

Act 64.

1. This order may be cited as the **Sales Tax (Exemption) (Amendment) (No. 5) Order, 1972**, and shall come into force on the 1st day of September, 1972.

Citation and commencement.

2. Schedule B to the Sales Tax (Exemption) Order, 1972, is hereby amended by adding immediately after item 51 thereof the new items as appearing in the Schedule hereto.

Pindaan bagi butiran 7 dalam Jadual Keempat. P.U. 173/59. 2. (1) Jadual Keempat dalam Kaedah<sup>2</sup> Kereta<sup>2</sup> Motor (Pendaftaran dan Pelesenan), 1959 (kemudian daripada ini di-sebut Kaedah<sup>2</sup>) ada-lah dengan ini di-pinda dengan memasukkan sa-lepas sahaja butiran 7 yang terdapat dalam-nya dan sa-belum butiran 7A, perenggan baharu yang berikut—

“When the fees payable on first registration of the motor vehicle was waived or reduced, there shall be paid in addition to the fee set out above the following proportion of the amount of those fees not paid on first registration—in respect of the fees payable under items 4 and 5, if the period that has elapsed after first registration is:

- (i) 1 year or less ... .. 80 per cent
- (ii) more than 1 year but not more than 2 years 60 per cent
- (iii) more than 2 years but not more than 3 years 40 per cent
- (iv) more than 3 years ... .. 20 per cent.”
