EMPLOYEES' SOCIAL SECURITY ACT, 1969

EMPLOYEES' SOCIAL SECURITY (GENERAL) REGULATIONS, 1971

RELAXATION OF PERIOD OF VALIDITY OF THE CONTRIBUTION CARDS (KUALA LUMPUR AND PETALING JAYA) ORDER, 1972

IN exercise of the powers conferred on him by regulation 111 of the Employees' Social Security (General) Regulations, 1971, the Minister of Labour and Manpower hereby makes the following order: P.U. (A) 99/71.

1. This order may be cited as the **Relaxation of Period of Validity of the Contribution Cards (Kuala Lumpur and Petaling Jaya) Order, 1972**, and shall come into force on the first day of June, 1972. Citation and commencement.

2. The contribution period of six calendar months provided under paragraph (2) of regulation 21 of the Employees' Social Security (General) Regulations, 1971 is hereby relaxed in respect of Kuala Lumpur and Petaling Jaya and the period in respect thereof shall be from the first day of June, 1972 to 31st day of December, 1972. Relaxation of period.
