EMERGENCY (ESSENTIAL POWERS) ORDINANCE No. 87, 1971

IN exercise of the powers conferred by subsection (2) of section 8 of the Emergency (Essential Powers) Ordinance No. 87, 1971, the Minister hereby makes the following order: P.U. (A) 72/71.

1. This Order may be cited as the **Incorporation (Amendment of Schedule) Order, 1971.** Citation.

2. Sub-paragraph (1) of paragraph 1 of the Schedule to the Emergency (Essential Powers) Ordinance No. 87, 1971, is hereby amended by substituting therefor the following— Amendment of Schedule. P.U. (A) 72/71.

“(1) There shall be appointed by the Minister three representatives of the Federal Government as members of a corporation.”
