MALAYSIA ACT

IN exercise of the powers conferred by section 74 of the Malaysia Act, 26/63, the Yang di-Pertuan Agong hereby makes the following order:

1. This order may be cited as the **Evidence Ordinance (Extension) (Amendment) Order, 1971.** Citation.

2. Article 3 of the Evidence Ordinance (Extension) Order, 1971, is hereby amended by substituting the following for paragraph (2): Amendment of P.U. (A) 261/71.

“(2) The Evidence Ordinance of Sarawak is hereby repealed except for sections 25, 92 and 170 to 180.”.
