NOTICE OF EXEMPTION UNDER SUBSECTION 73(1)
(ETERNAL MEMORIAL GARDEN BERHAD)

IN exercise of the powers conferred by subsection 73(1) of the Interest Schemes Act 2016 [Act 778], the Minister exempts Eternal Memorial Garden Berhad from complying with section 47 of the Act, in relation to the interests in the trust deed for the Eternal Memorial Garden Scheme, with effect from 1 August 2026 subject to the condition that Eternal Memorial Garden Berhad shall comply with any guidelines in relation to interest schemes issued by the Companies Commission of Malaysia from time to time.
