AKTA TAFSIRAN 1948 DAN 1967

PENJALANAN SEMENTARA FUNGSI-FUNGSI MENTERI

INTERPRETATION ACTS 1948 AND 1967

TEMPORARY EXERCISE OF MINISTERIAL FUNCTIONS

In exercise of the powers conferred by section 51 of the Interpretation Acts 1948 and 1967 [*Act 388*], the Yang di-Pertuan Agong has directed that during the periods specified in column (1) of the Schedule the functions of the Ministers specified in column (2) shall be exercisable by the Ministers specified in column (3).

CAPITAL MARKETS AND SERVICES ACT 2007

APPOINTMENT OF DATE OF COMING INTO OPERATION

IN exercise of the powers conferred by subsection 1(2) of the Capital Markets and Services Act 2007 [Act 671], the Minister appoints 1 April 2010 as the date on which the provisions in Division 2 of Part VI of the Act comes into operation.

AKTA KEMAJUAN PETROLEUM 1974

PEMBETULAN

DALAM Akta Kemajuan Petroleum 1974 [Akta 144] yang dicetak semula dalam tahun 2006 dan mengandungi segala pindaan hingga 1 Januari 2006—

- (a) gantikan perkataan “Petroleum Nasional Berhad” di mana-mana jua terdapat dengan perkataan “Petroleum Nasional Berhad”; dan
- (b) dalam teks bahasa Inggeris—
 - (i) dalam subseksyen 6(3B), gantikan perkataan “have” dengan perkataan “have”; dan
 - (ii) dalam subseksyen 8(2), gantikan perkataan “contrued” dengan perkataan “construed”.
