FREE ZONES (AMENDMENT) NOTIFICATION 1992

Act 438. IN exercise of the powers conferred by section 10(2) of the Free Zones Act 1990, the Minister makes the following notification:

Citation and commencement.

1. This Notification may be cited as the **Free Zones (Amendment) Notification 1992** and shall come into force on the 24th September 1992.

Amendment of Second Schedule.

2. The Second Schedule to the Free Zones Act 1990 is amended by inserting immediately after item 10 the following new item 11:
