AKTA PROFESION UNDANG-UNDANG 1976

PERINTAH DI BAWAH SEKSYEN 101

PADA menjalankan kuasa-kuasa yang diberi oleh seksyen 101 Akta *Akta 166.* Profesion Undang-Undang 1976, Jawatankuasa Tatatertib yang dilantik oleh Hakim Besar Malaya di bawah seksyen 99 Akta itu bagi maksud menyiasat suatu pengaduan terhadap Encik Goh Soot Hwang, peguambela dan peguamcara oleh (1) Encik Ali bin Suboh dan (2) Puan Noraini binti Sulaiman, telah pada 20hb Disember 1990 setelah menimbangkan keterangan-keterangan, membuat perintah berikut:

“Bahawa Encik Goh Soot Hwang, seorang peguambela dan peguamcara, dibatalkan dari daftarai Peguambela dan Peguamcara Mahkamah Tinggi di Malaya menurut seksyen 101 (1) (a) Akta Profesion Undang-Undang 1976.”.
